## The Empower Healing Project Declaration PART 1

### 1.0 PREAMBLE

1.1 Be it known to all that through the Divine Grace of Reiki and the Karma Quotient Force ("KQ Force"), AND the initiative of the mystic karmic healing masters Nalin K. Nirula and Renoo Nirula ("Living Masters") for the purposes of the activities detailed in this Declaration these Activities and all Empowered Participants thereof, direct and indirect, shall constitute the EMPOWER HEALING PROJECT (the "Project").

### 2.0 CREDENTIALS

2.1 Nalin K. Nirula and Renoo Nirula declare that they are duly spiritually empowered karmic healing Masters and Healers with Reiki and the KQ Force, in the lineage of Master Mikao Usui and the Masters Chujiro Hayashi, Hawayo Takata, Phyllis Lee Furomoto, David Jarrel, Harjeet Lamba; AND previously graduates of the Gaudiya Vaishnava Brahma Sampradaya, in the lineage of Sri Krishna, Sri Chaitanya Mahaprabhu, Bhaktivinode Thakur, Gaur Kishore das Babaji, Bhaktisiddhanta Saraswati Thakur, A.C. Bhaktivedanta Swami Prabhupada, Bhaktirakshak Sridhar Swami whose successor disciple Bhaktisundara Govinda Maharaj initiated Nalin K. Nirula with Hari naam and the dvija spiritual name and designation of Nayan Abhiram Das Adhikari Dev Sarman, and Renoo Nirula was given the spiritual name of Shyama Sundari devi-dasi initiated into Hari naam by Gopal Krishna Swami, disciple of A. C. Bhaktivedanta Swami Prabhupada. By the grace of Divine Providence and the blessings and support of Spiritual Masters, Nalin K. Nirula and Renoo Nirula are following the unconditional spiritual path of Reiki and KQ Force. In all these efforts the objective has been and is to serve the causes, purposes and desires of the Supreme Divine Original Source of All Sources, and Creator of the Universe.

### 3.0 CHARTER OF ELIGIBILITY, AUTHORITY, POWERS & PRIVILEGES

- 3.1 The Living Masters further declare that along with their created spiritually empowered Reiki and KQ Force healers and masters currently in good standing ("the Healers"), they jointly and severally have the empowerment, authority, qualification, and right to modify existing chains of cause and effect of karmic consequences arising from the Laws of Karma and the Universal Justice System on the following grounds:
- a. That the energies of Reiki and the KQ Force are directly originating from the Supreme Source of all sources, and maintain their original quality and nature of being non-different from the quality, quantity and nature of the Supreme Source of all sources which are Individually and severally termed as the "Divine".
  - b. Reiki and the KQ Force are additionally the Divine life-force support and protective energies of all living entities whose unchanging constant

essence ("soul") is of a nature identical to that of Reiki and the KQ Force, and which energies remain constant and unchanged through the various bodily and elemental transformations of the bodies of living entities. The eternal and indestructible energies of Reiki and the KQ Force are declared to be qualitatively and quantitatively superior ("spiritual nature") to the 5-element based transformational energies of changeable nature and matter in the space-time continuum ("material nature").

- c. The spiritual nature of the soul while being qualitatively superior to material nature, is presently bound in the material nature and has the capability of being released from binding matter by the Grace of the Divine.
- d. By Supreme Divine Will and Order, Reiki and the KQ Force energies have the authority to change the binding karmic consequences of living entities and created objects in the universe (the "Healees"), beyond the Laws of Karma and the Universal Justice System and can therefore override the application of and consequences arising from the Laws of Karma and the Universal Justice System, as previously applicable to the Healees.
- e. For clarity it is stated that "binding karma" is that sum total of karma and karmic consequences that requires individual living entities to keep returning to the material nature universe to balance their books of karmic account and which activity is the simultaneous cause and result of the "Karma Syndrome" consisting of the repetitive cycle of birth, disease, old age and death.
- f. That the Healers channeling Divine Reiki and KQ Force energies empowered by and with the grace and support of the living masters in their spiritual lineage, have the unrestricted right to utilize the Divine energy empowerments to petition the Supreme Divine directly through their mandate for the altering, amending, modifying, changing and otherwise waiving off partly or wholly, or unconditional pardoning of binding karma and karmic consequences arising from the application of the Laws of Karma and the Universal Justice System for the relief of suffering of all the Healees. Such petitioning activity ("Healing") is authorized by the Order and Will of the Supreme Divine.
- g. That the Healers have commenced the process of so healing their own balance of binding karmic consequences, and have experienced directly the results of Divine Healing at first hand. In this process, the Healers have begun to illuminate their lives and the lives of those around them with spiritual karmic healing power of the Divine, and the Healers have understood the desirability of being healed of the Karma Syndrome and be restored to their full spiritual potency, and desire to help others similarly in the service of the Divine.
- h. Out of compassion for the suffering living entities, and by the empowerments vested in them through the grace and support of all the spiritual masters in their lineage, the Healers have the right to act in all

such appropriate ways to progress petitions of pardon for other Healees whether the Healees request this or not. That the Healers have the absolute right to decide the object of Healing, where to channel Healing and for what purpose and with what intensity and dedication.

- i. While the healers understand that they have the absolute right to pursue pardon and relief petitions and procedures for relief from binding and suffering karma for the Healees, the results are entirely at the Pleasure and Will of the Supreme Divine.
- j. That any personal consequences to Healers arising from the Healing undertaken for the Empower Project are free from binding karma for them, and additionally enable them to heal and make peaceful their lives in all areas of existence--the material as well as to further enhance and reveal the spiritual.
- k. That the Healers participating in the Empower Healing Project individually declare that they are empowered lawfully with the Divine spiritual karma-changing and healing energies of Reiki and/or the KQ Force, and that their connection to these energies are currently valid and in good standing through the Grace of the Living Masters.
- l. By the Grace of the Divine, any defect, shortcoming, fault or offense known or unknown, due to any reason on the part of any of the Healers in their activities either for fulfillment of the Project goals or in their daily life and living may be forgiven and excused and treated as of having no consequence, with such Healer receiving, accepting and acting upon knowledge on how to adequately rectify, overcome such defect, shortcoming, fault or offense.
- m. The Healers pray to the Divine that they always remain under the shelter and protection of the lineage of their spiritual masters, Reiki, the KQ Force and the Supreme Divine.

## 4.0 JURISDICTION, AND HEALERS' AUTHORITY TO ACT

4.1 The Healers acknowledge that they are bodily situated in, and working in the zone of the material elemental and space-time continuum existence that is the operational jurisdiction of the respective Administrators of the Universe ("Administrators"), under the powers granted them by the Supreme Divine Source of all sources.

4.2 The Healers further acknowledge the power and position of the Administrators and respectfully submit that by virtue of the credentials and authority presented in Clauses 2.1 and 3.0, the Healers are authorized by the Divine to pursue their work of karmic healing for the relief of all Healees in all zones of the Administrators jurisdictions from the highest to the lowest, and request all cooperation, assistance and support of the Administrators for the purposes of the Empower Healing Project which is a service for the Supreme Divine directly.

## 5.0 THE MISSION CHARTER

- 5.1 Nalin K. Nirula and Renoo Nirula submit that their Mission undertakes that they and the Healers heal the Karma Syndrome, permitting relief and pardon of karmic consequences for immediate and future longer term situations for Healees throughout material creation. The nature of specific healings is detailed in Part 2 of this Project Declaration, and these statements and affirmations detailed may be amended from time to time as deemed appropriate, and shall constitute the active working part of the Empower Healing Project Mission.
- 5.2 Nalin K. Nirula and Renoo Nirula further state that the ultimate objective of Healing is to extract the Healees from the material zone of existence and Jurisdiction of the Administrators, enabling transfer of Healees to the Absolute or Spiritual love and light zone of existence in the Spiritual Universe, through their healing work to neutralize, revoke, waive off and cut short all pending karmic consequence dues of the Healees. That this objective is in complete harmony with the stated desire of the Supreme Divine, Who graciously permits the individual living entity to decide this according to individual freedom of will.
- 5.3 In the material condition of existence, as the individual soul is suffering from the Karma Syndrome disease, it has become forgetful of it's true spiritual nature and it's essential quality and hence has lost it's individual free will. The individual will is contaminated and driven by conditions that do not sufficiently permit the action of free will. The Healers undertake healing so that the Healees true and essential spiritual nature becomes restored to a level of spiritual consciousness that they are able to make a decision of their own true free will illuminated by a consciousness that is not contaminated or biased by matter and the consequences of the Karma Syndrome.
- 5.4 In order to fulfill the desire of the Supreme Divine, and to help create the conditions for the materially conditioned souls to exercise true free will, the Healers have voluntarily undertaken this additional Healing work specifically and at large.
- 5.5 That the Healers humbly submit to the Administrators of the material zones of existence that recognition be awarded to the authority of the Empower Project Mission of the Healers under the credentials presented by Nalin K. Nirula and Renoo Nirula, the Living Masters, requesting all assistance, help and support for furthering this Divine Mission of the Empower Project, which supersedes the normally applicable Laws of karmic consequences. The Healers express their gratitude to all who cooperate and assist in the Project and also to those who may otherwise give the Healers an opportunity to channel Healing for this Project in different ways.

### 6.0 General Affirmations

- 6.1 For the purposes of the Empower Healing Project and these healing affirmations, By Divine Grace and the Healing energies of Reiki and the KQ Force, all past, present, future and pending chains of karmic consequences have been re-written, modified, adjusted, neutralized, cancelled, as may be appropriate, AND new directions of consequences and effective results have manifested for the general and specific welfare of the planet and the living entities thereon. In all situations and circumstances the Healers and their associates are protected and supported by the Divine as well as the Administrators of the Universe and their agents.
- 6.2 The planetary chakras of the planet and the people living in various lands and nations are healed sufficiently such that there is protection and welfare of the citizens as opposed to the welfare of the corrupt ruling classes and their associates.
- 6.3 These specific chakras of the planet and the people living there are healed whole and complete, the healing capacity of the earth planet is fully restored with all negativities transformed and neutralized, and/or sent back to the source where appropriate:

## 7.0 Specific Affirmations
